I. Course Information

A. Catalog Description

This course provides a comprehensive exploration of the fundamental principles of criminal law through an in-depth examination of criminal offenses and their classifications. Students will study the essential elements of various crimes, the range of potential punishments, intricacies of accomplice liability as well as a thorough analysis of key defenses to criminal charges,

Upon successful completion of this course, the student will be able to:

1. **Synthesize Knowledge on Crime Classification and Punishments:** Construct a comprehensive framework that categorizes crimes and examines how the U.S. legal systems determine appropriate punishments.

3. **Critically Examine and Distinguish Anticipatory Offenses:** Compare and contrast conspiracy, solicitation, and attempt, evaluating their legal implications and the ethical considerations surrounding each type of offense.
4. **Evaluate Various Defenses to Criminal Culpability:** Investigate and critique the effectiveness of different defenses against criminal charges, considering case law and the impact of these defenses on judicial outcomes.
