# **Critical Thinking Skills**

Students will identify the key aspects of the U.S. Congress as an institution. Students will research, evaluate, and compare information from varying sources in order to

evaluate authority, accuracy, recency, and bias relevant to what it takes for Congress to effectively carry out its constitutional duties. They will generate solutions to/analysis of various issues that impede Congress's ability to fully play its role as the legislative branch of the U.S. government. Students will assess and justify the solutions and/or analysis of Congressional actions.

#### **Quantitative Reasoning Skills**

Students will apply appropriate statistical models to understand the actions of U.S. lawmakers. Students will represent statistical information symbolically, visually, numerically and verbally and will interpret models and data in order to draw inferences on the effectiveness of Congressional members. They will recognize the limitations of quantitative analysis.

### **Communication Skills (Written and Oral)**

Students will develop the ability to proficiently articulate and defend their opinion in front of their peers by composing coherent documents appropriate to get their points across to the class and to the instructor. They will also effectively communicate orally in a public setting.

# **Ethical Decision Making**

Students will identify ethical dilemmas that congressional members often face and apply ethical frameworks to resolve a variety of ethical dilemmas associated with being a U.S. lawmaker.

#### **Global and Cultural Perspectives**

Students will reflect upon legislative differences and their implications for consuming news from political cultures other than their own. They will demonstrate understanding of the U.S. Congress in a global environment.

Students will also demonstrate how the U.S. Congress impacts or is impacted by different political cultures.
